



Overview of 49 civil society initiatives implemented under the EU Civil Resilience Mechanism





"The symbol of Helix communicates the idea of Resilience as an ability to withstand, adapt and grow. It is in all of us and can be learned and developed in anyone, like the nature itself. We can trace the helix in every living organism, the nature and surrounding."

Background Information:

Civil society organisations have already played an important role in preparing society in the Republic of North Macedonia for EU accession, being involved in different sector reforms. Through their active civic engagement, advocacy and oversight role, CSOs contribute towards further democratisation of society, hold government accountable and enhance policy-making and dialogue with the institutions and the EU. Engaging civil society organisations in the EU negotiation dialogue is essential to ensure inclusiveness and understanding of accessionrelated reforms and that undertaken commitments are not just institutional, government-led exercises but are accessible to citizens based on meaningful consultations and genuine civic participation. To ensure those results, civil society requires strategic, long-term support that ensures their uninterrupted operation and constant upgrading of their capacities.

In this line, the EU has been supporting the needs of civil society for an improved enabling environment in the country through the IPA Civil Society Facility (CSF) Programmes since 2008. The programme has proven to be a powerful means to strengthen, through civil society, participatory democracies, rule-of-law, key sector reforms and alignment with core European values, which, in turn, foster accelerated social and economic convergence.

The opening of the EU accession negotiations with North Macedonia in 2022 was not only an important milestone for the country's progress but also required the mobilisation of the citizens and entire society for the demanding sector reforms at many levels. Recognising the important role of the civil society, to foster a citizenry that is not only more engaged but also infused with innovation, creating a brighter and more resilient society for all, the European Union has launched the EU Civil Resilience Mechanism (EU CRM) in 2022¹.

The EU CRM is an in-kind support for small civil society organisations and grassroots to implement actions serving to local communities all over the country, and strengthening the citizens' resilience during frequent social changes. The main objective of the CRM support is to contribute towards improved environment and capacities of civil society for efficiently addressing the key reform priorities by fostering dialogue and structural cooperation between institutions, civil society and business community, and empowering citizens and quality of their lives.

Under the CRM support, the EU has awarded 0.9 MEUR supporting 49 civil society initiatives implemented in the course of 2023/2024. The awarded civil society organisations were enabled to undertake effective actions to promptly respond to real needs in their communities and strengthen the citizens' resilience, but also informing the citizens, objectively and promptly, on the EU accession process and related sector reforms and their real impact on citizens' daily lives.

In particular, the awarded civic initiatives cover <u>five</u> <u>priority themes</u>: 1) empowering CSOs for legal and policy engagement, 2) advocacy and watchdog; elevating 3) interactions with institutions and the business community; 4) uplifting democracy and human rights advocacy; enhancing CSO visibility and communication; and 5) fostering cross-CSO collaboration. At core of these actions, is embodied the principle of human rights-based approach, delivering tailored solutions for citizens to act as catalysts for positive transformation in their communities, guided by inclusivity, non-discrimination, and accountability principles.

Furthermore, the 49 civic initiatives are aligned with the six EU values: safeguarding human dignity, promoting freedom, strengthening democracy, advancing equality, upholding the rule of law, and protecting human rights. These projects signify tangible actions towards democratisation of the society and installing these EU values in the local commutes.

Unlike standard grant programs, the EU CRM support strategically minimizes administrative burden, directing substantial in-kind support to small civil and grass-roots organisations to deliver prompt and efficient actions for their communities in need. Beyond financial support, the CRM provide for mentoring and capacity-building to empower the awarded CSOs to actively shape a resilient society, fostering proactive governance, encouraging collective action, and building bridges to inclusivity in all regions of the country.

The CRM support has a **significant geographical coverage**, weaving a transformative web across the country, ranging from six (6) nationwide initiatives, nine (9) in Skopje, to thirty four (34) region-specific actions, covering the regions of Polog, Pelagonia, Vardar, Eastern, South-Western, and South-Eastern part.

The civic initiatives served as catalysts for transformation, influencing local policies, amplifying advocacy, promoting human rights and their protection, gender equity, youth empowerment, cultural and environmental awareness and protection, socio-economic growth and job creation and overall, contributing to more inclusive, just, and empowered society, positively impacting lives of local communities and overall citizens of the country.

These initiatives **targeted various groups of beneficiaries**, including vulnerable groups, marginalised communities, local government and institutions, media and business community, and the broader public, aiming to make a positive impact and contribute to collective societal wellbeing.

In this context, the CRM proved to be an important financial mechanism in expanding the EU partnerships with grass-root civil society organisations in North Macedonia to further strengthening the local communities for maintaining the social cohesion and for shaping the socio-economic recovery toward a more equitable, gender responsive and environmental-friendly society.

This introduction is followed by an <u>overview presenting</u> the 49 awarded projects implemented by civil society <u>organisations across North Macedonia</u>, each contributing to societal betterment and <u>aligning with European Union values</u>.

While no specific order exists for listing the projects, they are colour-grouped according to the EU value related to their type of action.

These gatherings are designed for exchanging insights, camaraderie, and shared experiences among those bearing the weight of MS. Promoting socialisation, these groups facilitate a profound connection between MS warriors and their devoted family members/caregivers.
- MS Day Marvel: Annual Event to honour World MS Day (May 30th). This celebratory occasion raises awareness to the public and bringing the MS community together to strengthen bonds and amplify advocacy.

 Digital chronicles: promotional and informative narratives through paid advertisements on social media. This digital domain serves as an avenue for disseminating valuable insights and fostering a sense of belonging among those facing the MS.

WHO:

WHAT:

- School selection and cooperation agreement: identify target schools and establish cooperation agreements for project activities.
- Public communication materials design and production: create printed materials for public communication, including t-shirts, leaflets, posters, and banners.
- Waste education kit preparation: develop a waste education kit focusing on source separation and integrated waste management. Conduct a study on waste pollution and its consequences in a UNESCO Heritage region.
- Training of trainers/teachers: train teachers on the importance of waste separation at the source.
- Launching a competition and plastic recycling container delivery: initiate competition among schools, deliver plastic recycling containers, and provide schools with competition forms on waste separation and management.
- Student-led waste separation: organise and supervise waste separation at the source by school students.
- Award ceremony for winning schools: host an award ceremony to recognise and celebrate the achievements of winning schools.

 Round table discussion: conduct a round table discussion at the end of the project involving all project stakeholders, local authorities, and waste management enterprises.

WHY:

- To increase awareness among young people about the importance of resource allocation and integrated waste management, emphasising the negative consequences of neglecting this process for the region's future.
- To support government measures for implementing a waste management strategy, including potential cooperation in piloting waste management initiatives in neighbourhoods of Ohrid and Struga cities.
- Align with UNESCO's recommendations for the Ohrid Lake region as a UNESCO Site, fostering a clean environment and sustainable tourism development.
- Address thematic areas related to EU integration and environmental and climate change issues.

ALL IN ACTIONS FOR SAFE SCHOOLS

WHAT:

- Peer violence training sessions: a cornerstone of the project involves conducting in-depth peer violence training sessions for educators and school staff. These sessions serve as a vital knowledge transfer platform, equipping professionals with the tools and insights needed to effectively identify and address instances of peer violence.
- Consultative support: the project extends consultative support to teachers and school staff, ensuring they have access to guidance and expertise when faced with the complexities of peer violence situations.
- Interactive workshops: engaging high school students through interactive workshops is a pivotal aspect of this initiative. These workshops provide a safe space for students to explore the nuances of peer violence, fostering understanding, empathy, and constructive responses.
- Regional expert work meetings: two regional expert work meetings are slated, where school staff and representatives from relevant institutions converge. These meetings serve

- as hubs for dialogue and collaboration, driving systemic improvements in dealing with peer violence.
- Preventive plan development: the project actively engages in the development of a comprehensive plan for prevention activities. This roadmap aims to address peer violence and create a safer educational environment proactively.
- Policy brief creation: the project team is dedicated to producing a Policy Brief that advocate for enhanced legal regulations and the creation of robust mechanisms for addressing peer violence. This document seeks to influence policy and legal reforms in favour of safer schools.
- National conference: as a crowning achievement, the project will organise a National Conference. This event serves as a platform for promoting the establishment of legal regulations and a systemic approach to addressing peer violence. It aims to bring together stakeholders, experts, and decision-makers to catalyse change.

WHO:

WHAT:

- Development of youth activity instructions: creating a set of instructions for planning and implementing youth activities.
- Joint training plan: collaboratively developing a training plan for the Regional Network and platform, with at least two joint activities per year, in cooperation with the Scout group Mija Stanimirovic in Nis (Serbia).
- Volunteer camp: organising a volunteer camp at IC Golozinci for 50 young people to carry out visible youth actions and promote traditional scouting.
- Creative camp for education: conducting a creative camp in Scout Center Golozinci, involving 50 young people in informal education and communication skills.
- Common songbook: Create a common songbook (with chords) featuring traditional and modern songs from each country.
- Traditional meals book: compiling a book on shared traditional meals, translated into local languages.
- Camp for participants: organising a camp for at least 50 participants, focusing on training young scouts to implement intercultural exchanges.
- Educational camp: conducting an educational camp covering project writing, project cycle management, motivational skills, topography, orientation, and first aid.

- Organising a two-day workshop focused on representation and lobbying for participants from local rural communities, municipal representatives, and council members.
 Additional workshops on civil engagement in local-level decision-making, involving 20 representatives from both municipalities, was also conducted.

- Gender equality training: implementing training sessions on gender equality and EU integration processes in rural areas, fostering a more inclusive and balanced approach to local governance.
- Policy brief creation: providing coaching and mentoring for developing policy briefs. This support will empower local community representatives to craft at least two policy briefs, one for each municipality.

- Road safety defenders: A volunteer forum is established to encourage young people to develop SMART-based activities that enhance planned project activities. This approach empowers young individuals to contribute to traffic safety solutions.

- Media collaboration: Collaborating with media outlets to promote project activities.
